A commercial truck can be as much as 20 times the weight of a standard passenger vehicle at 80,000 pounds.

Truck accidents cause more severe injuries and fatalities than other types of accidents.

When a big truck is involved in an accident with a much smaller car, even at a lower speed, the results are often tragic.

When an accident occurs between a big truck and a passenger vehicle, the occupants of the vehicle sustain much more significant injuries than those inside the truck. Around 82 percent of fatalities in these accidents are of those in smaller cars, on bicycles or on foot. Passenger vehicles offer little protection from the impact of a truck of that size.

Truck accidents often cause significant injuries to non-truck occupants



Texas leads the nation in the number of large truck accidents

A large truck is defined as trucks with a gross vehicle weight rating more than 10,000 pounds. As a large state with a large population and more roads, this makes sense statistically but is nonetheless an unfortunate figure. There were 556 fatal truck accidents in Texas in 2017, which resulted in almost 650 deaths. In addition, there were more than 1,500 big truck accidents resulting in serious injury.

There are roughly 500,000 accidents involving a big truck nationally every year. Of those, 4,761 people were killed in 2017 according to data from the National Highway Transportation Safety Administration (NHTSA).

Texas truck accident statistics:

There were 556 fatal truck accidents in Texas in 2017, which resulted in almost 650 deaths. In addition, there were more than 1,500 big truck accidents resulting in serious injury.

Common Causes of Truck Accidents

Even though professional truck drivers are highly trained to operate their trucks, the immense size and reduced maneuverability of big trucks can contribute to a serious accident from one seemingly small mistake.



Driver Fatigue

02

Truck drivers are often under intense pressure to make their deliveries as quickly as possible. Even though there are laws which dictate how many hours truckers can drive and how many hours they must rest, they sometimes are not enough. Driving while tired is especially dangerous when operating a tractor trailer.



Negligence

Whether the driver of the truck or another motorist who is at fault, failure to use adequate caution is the most common reasons for an accident. Drivers that fail to obey traffic laws and patterns can easily cause an accident.





Impaired Driving

Operating a vehicle either while under the influence of drugs or alcohol or while distracted by a phone or other device causes too many preventable accidents.

Reckless Driving

Speeding, unsafe maneuvering and more contribute to many crashes, especially around big trucks that have areas of little to no visibility.





Equipment Failure

05

Big trucks and trailers require special maintenance. Mechanical or cargo issues can create unsafe conditions. Common examples of this include brake failures, tire problems and improperly loaded trailers.

Road Conditions



Weather and road conditions may cause unavoidable accidents.

Establishing Liability in a Texas Truck Accident

All commercial truck drivers and the companies who employ them must abide by state and federal laws to maintain safety. These laws dictate things like the number of hours drivers are allowed to drive, how much they should rest, maintenance, record keeping, licensing, weight limits, required equipment and more. Not following these laws leads to dangerous, often avoidable, accidents.

In the US, driver negligence is the primary cause of 87 percent of all truck accidents.

More than one party may be liable in your truck accident case

The actions of multiple parties could have contributed to an accident and therefore more than one party can be found liable for any resulting injuries. The driver of the truck, another driver on the road,the owner of truck or trailer, a shipping or loading company, maintenance company, manufacturer, receiver, and other could potentially share liability depending on what caused the accident.


